


### Message From The Chairman of the Board Lee J. Millas, Ahepa Board of Trustees

### VISA WAIVER EXPANSION

#### Expert panelists share their insight on its possible expansion

Ashington, D.C. - The American Hellenic Educational Progressive Association (AHEPA), theleading association for the nation's 1.2 million American citizens of Hellenic heritage held an AHEPA forum, "Visa Waiver Program: 2007 A Year for Expansion?" on Capitol Hill on Friday, January 19. The program, was a success with panelists representing various facets of the US and European Governments.

The expert panelists included: Baxter Hunt from the US Department of State; Ambassador Angelos Pangratis from the Delegation of the European Commission; Nathan Sales from the US Department of Homeland Security; Jeannie Siskovic from the office of US Senator George Voinovich and Daniel Griswold of the Cato Institute.

"We believe that the Visa Waiver Program and its potential expansion, to include Greece, is currently at the forefront of discussion in Washington," said Gus J. James, II, AHEPA National President. "Moreover, in order to continue the dialogue of expansion, we believe by hosting an informational forum we can continue to play a vital role in educating the public about the program's benefits.

"We have been in the lead on this issue by creating awareness of Greece's qualifications as a Visa Waiver nation to key members of Congress and federal agencies. Greece certainly is wellpositioned for entry based on its own merits and we believe that through its admission a lot of goodwill will be generated between all countries involved."

James added he expects there to be significant progress in 2007 and AHEPA will remain engaged in seeing this process through to completion.

### Eagle Rock Chapter #375 Wins National Award for Most Money Raised for the AHEPA Bone Marrow Registry



The District Lodge visited Eagle Rock chapter #375 of Orange, NJ on Tuesday, November 7th. The visitation was a special night as District Governor Ted Vittas brought with him a plaque to recognize Eagle Rock for being the chapter to raise the most money for the AHEPA Bone Marrow Registry. The chapter raised over \$1,500, edging out Chicago, Illinois for raising the most money. Led by Brother Angelo Pantazes the chapter used a canister drive and solicited individual donations to raise the sum. Receiving the plaque was Brother Angelo and President Peter Kokidis.

Earlier in the year, the plaque was awarded to the District Governor at the Supreme convention floor in Hollywood, Florida. Together with money raised by Morris County 300, District 5 also received a top honor for being the top district to raise money for the Bone Marrow Registry.

Brother Pantages gave those present at the meeting a short history of the Registry. The donations are used to gather blood samples and enter the blood type in a massive database. The database would be used to match donors to the blood type of someone suffering from a blood disorder like Leukemia. If a match is found, a bone marrow transplant is performed from the donor in order to cure the patient. The chances of finding a compatible match to a donor, however, is extremely rare. Your chances to find a match are improved when you attempt to match with someone of the same ethnic origin as the patient.

The Registry is now run by a group of Ahepans in Chicago. Brother Pantages and his brothers from Eagle Rock had been leading the registry for many years. We are indebted to him for his dedication toward this cause over the year. 

T's hard to believe, but another Winter has passed and it is time to think about Easter and then summer vacation. I remember when I was a little girl in New York City, how excited my sister and I would be at this time of year. The trees would be starting to get green, flowers would be blooming and of course it was time to go shopping for our new EASTER OUTFITS, COMPLETE WITH BONNETS. And of course, Easter Sunday, after Church to stroll up and down Fifth Avenue dressed in all our glory, to go and see others, and, of course, to be seen. We Greek-Americans kept the traditions of the "Patrida" just as strongly, and sometimes more so, than the people who live here. To this day, you cannot find a "hasapotaverna" open in all of Astoria, New York, during Holy Week.

amden Chapter No. 69 was organized on June 4, 1925. Thirty six members were installed that evening. There was such great enthusiasm generated about this new organization, that by the year's end, this thirty six had increased to sixty.

For many years, Camden Chapter did not have permanent quarters. In 1947, out of the Camden Chapter, grew an organization named "American Hellenic Orthodox Centre." All their elected officers were Ahepans. A building was purchased in 1954 by the American Hellenic Orthodox Centre in Camden, where the AHEPA was given the second floor for a meeting room and the third floor for the Greek language school. Some years later, the Greek Orthodox Church of Camden County was established and from this came St. Thomas Greek Orthodox Church. The



Lagakos, Vias President; Angelo Zonia, Chaplain. ground on which the St. Thomas Church and Cultural Center are built was purchased by the American Hellenic Orthodox Centre, whose leaders had the foresight to realize, that for our Hellenic community to grow, we needed room. The building in Camden was sold to the city renewal program, and the proceeds donated towards the erection of the St. Thomas Church and Hellenic Cultural Center. In the Hellenic Cultural Center, Camden Chapter has one of, if not the finest, AHEPA meeting room in all the AHEPA domain.

The name "American Hellenic Educational Progressive Association" emphasizes education. It is not education as we think of it today, such as high school and college, but rather education about the laws that govern the new country to which the Greeks emigrated. In accordance with the oath and obligation taken as candidates




Left: Jewel Case built by District 5 PDG and Past Chapter President Julian (Woody) West – Right: Camden Chapter No.69 Banner

for membership, Camden Chapter instructed Greek immigrants in how to apply for citizenship. The Chapter also realized that the Greek language and heritage needed to be preserved. In 1929, the chapter established a Greek evening school. From that meager beginning, the St. Thomas community can now boast of having one of the finest Greek language schools in the Delaware Valley area and beyond. Each year, Camden Chapter presents the "AHEPA Medal for Scholarship Excellence" to the outstanding student in the Greek language school.

Higher Education is also of high importance to Camden Chapter. In 1965 one of its members established its first Scholarship Fund. Other Scholarships have since been established by families of some of the chapter's deceased members. Camden Chapter's scholarship funds have given grants totaling \$75,000 to date.

At the District level, four of its members distinguished them-

selves by becoming District Governors. The chapter has hosted six successful district conventions in '48, '58, '67, '75, '89, and 2000, the last one commemorating its 75th anniversary. One of its members was instrumental in establishing the AHEAP Fifth District Cancer Research Foundation. This foundation raises funds which are donated to be used for cancer research in the hope that some day a cure can be found to eradicate this disease.

Camden Chapter has hosted many benefit dances, with all proceeds going to different charitable organizations. It hosted dances to benefit the 5th District Cancer



Research Foundation, Deborah Hospital, Cooley's Anemia, and the purchase of a pulse oximeter that is located in the neonatal nursery at the West Jersey Hospital. The nursery is a care center where the new born child is examined by the surgeon. The chapter supported the Cyprus Relief Fund and, for several years, adopted a Greek Cypriot refugee.

Annually, Camden Chapter hosts dinner meetings honoring its "Old Timers" and the "Past Presidents" of the chapter. Each year, a memorial service is conducted for deceased members. In 1975, Camden Chapter celebrated its 50th Anniversary, where we the surviving charter members were honored, with Senator Paul Sarbanes as toastmaster. In the early years, the chapter had an excellent degree team.

This biography has only

touched the surface of the chapter's history. Camden Chapter 69 is still very active. Last year, it sent a busload of 35 attendees to AHEPA Biennial Banquet in Washington, D.C., honoring retiring Senator Paul Sarbanes and Congressman Michael Bilirakis. Two of its members currently serve on the District Lodge and its initiations each year would bring pride to the members of Camden Chapter's famous Original Degree Team of years gone by.

ur beloved, The Very Rev. James N. Chakalos was taken from us on September 4, 2006.

Father Jim was born in Keene, N.H. in 1924, and served in the Army during World War II, and fought at the Battle of the Bulge. After the war, he was employed by the U.S. Government, with his last assignment as the housing referral officer.

When he retired, he decided to pursue his lifelong dream of becoming a priest. Father Jim was ordained in 1972, and served at St. George, Asbury Park, St. Barbara, Toms River, and finally at Kimisis Tis Theotokou, Holmdel.

Father Jim was a proud 52 year member of AHEPA, and served as President of Thomas Edison #287, Asbury Park in the 1960's. On Tuesday, March 6th at St. Constantine & Helen Church in Orange, NJ, Ms. Angelique Lampros author of the book "Remembering Newark's Greeks An American Odyssey" made an audio-visual presentation on her work. The book is a compilation of pictures and stories of Greek immigrants who settled in the NJ's largest city, Newark, NJ. The time period ranged from the 1920s to the 1960s. While a slide show of the pictures were projected on a screen, Ms. Lambros read countless stories recalled by the subjects themselves. They recalled how they made it to America, the jobs they held, their life in the big city. Many in the audience, which was more than 50, had family members mentioned in the book.

### Letter from Gus D. Stefanidis Supreme Vice President



### **Biennial Salute to Women Honoring Cleopatra G. Notarides**

leopatra G. Notarides was born in Jersey City, New Jersey in 1943. The only child of Evelyn Karagounelis and Andrew Notarides, she was raised in the Jersey City Evangelismos Greek Orthodox Church community. Serving as the President of the Ir. Goya, Cleo also taught Sunday school for twelve years.

This dynamic woman would be the first in many endeavors. Cleo was the first female President of the senior class at Dickinson High School. At the age of 19 she joined the Maids of Athena, serving the 5th District as Governor, shortly after she would serve on the Grand Lodge of the Maids of Athena as Grand Governor.

In 1966, Cleo was elected to serve as the Grand President of the Maids of Athena, making her the first elected Grand President to hail from the 5th District. Grand Presidents before her traveled hundreds and sometimes a few thousand miles, however as Grand President, Cleo traveled more than 20,000 miles visiting over 50 individual Chapters and 11 Districts across the country. With the assistance of the Daughters of Penelope a complete reorganization of headquarters was instituted involving the micro-filming of all past records, and updating of procedures. A new "Code of Ethics" was distributed; the Ritual was revised and reissued, as was the manual of instructions. During her tenure every District had at least one District officer, something never before accomplished. Further, six new Chapters came into the Order and ten chapters reactivated during her reign.

A graduate of Jersey City State College, Cleo earned her first Masters Degree in American History (Social History) from



Montclair State College and her second Masters Degree for Behavioral Science from Kean State College. For twenty-eight years she taught at Ridgefield Park Junior/Senior High School in Ridgefield, NJ, developing the first full-year Psychology course in Bergen County. In 1976 she was honored by the Bergen County PTA as High School Specialist Degree in Individual, Marriage and Family Therapy from Seton Hall University.

Cleo is the Executive Director of Individual and Family Institute Inc., Paramus, New Jersey as well as an instructor at the Bergen Community College Continuing Education Division. Further, she

> is the Bergen, Passaic and Monmouth Counties Family Court appointed case Evaluator and Expert Witness and is a Clinically Certified Forensic Counselor and Certified Grief Counselor.

> Over the years, Cleo has been a guest lecturer, at numerous seminars and training workshops as well as appearing on radio shows. She is a member of the American association for Counseling and Development and the American Association of Grief Counselors. In 1998 she was presented by NJ Governor, Thomas Kean, the Governor's Teacher Recognition Award. Appointed by NJ Governor, James Florio to the Governor's Committee on Children's Services Planning 1991-1993, she was also appointed by NJ Governor, Christine Todd Whitman to serve on the State Board of Marriage Counselor Examiners from 1995-1998. In May of 1994,





being only one of twenty mental health therapists, Cleo was invited by First Lady, Hillary Clinton, to attend the White house Conference on Health Care.

**E** ver since I was a little girl, I can remember my father being surrounded by lots of friends. Being active as he was in our church and in our community, there were always people, mostly men, who came in and out of our lives on a daily basis. They seemed to know what the other was thinking without speaking, and when they did speak, they always seemed to understand perfectly what the other was trying to say. And then there was the handshake.


I knew they were doing something when they shook hands, but I didn't know what it was. They thought it was their big secret; but it really wasn't. It began their encounter, and when they did it, there was a twinkle in their eye and a smile on their face. It was the customary opening act to their unscripted performance.

Whenever these special friends were around, I somehow felt safer, and the world somehow felt more secure because of their presence in it. They seemed to me like knights in shining armor, on great white steeds, patrolling their kingdom, ever on the lookout to do a good deed, right a wrong, champion the cause of the underdog, or help a damsel in distress. Whenever one was around, you could almost feel his power to do good, but when they assembled as a group, their power became magnified. When they closed ranks, there seemed to be no enemy that would not be utterly and completely vanquished by their steadfast charge.

To a little girl now grown and about to leave home to enter col-

lege, AHEPANS are still my knights in shining armor. The new and uncertain world I am about to enter is a better place because you are in it. May God grant you the ability to continue to patrol this great country of ours on your great white steeds, the sunlight of honor glinting off your shining armor, the warmth of integrity emanating from your unfurled banners. This damsel thanks you from the bottom of her heart for being the living embodiment of all that is good and right in this world.



March 27, 2007, Union, NJ - The District 5 AHEPA Basketball League ended its 2006-2007 season tonight as Middlesex, NJ successfully defended their 2006 league championship. 
